## Waiver and Release of Liability and Indemnity Agreement

In consideration of being granted a membership and/or competition license and in consideration of being permitted to enter competition events sanctioned by the American Racing Drivers Club, Inc.:

I, for myself, my heirs, personal representatives and assigns, hereby release, discharge, and agree to hold harmless and indemnify the American Racing Drivers Club Inc. its successors and assigns, and officers, directors, officials, representatives, agents and employees of them, of and from all liability, loss, claims, demands, possible causes of action, court costs, attorneys fees and other expenses arising from any lawsuit that may otherwise accrue from any loss, damage, or injury (including death) to my person or property in any way resulting from, or arising in connection with, or related to, any sanctioned event, and whether arising while engaged in competition or in practice or preparation therefore, or while upon, entering or departing from said premises, from any cause whatsoever including without limitation the failure to make inspections, or the negligence of other persons. I know the risk and danger to myself and property while upon said premises or while participating or assisting in a sanctioned event, and I do so voluntarily and in reliance, not upon the property, equipment, facilities and existing conditions furnished by others, but upon my own judgment and ability, and I thereby assume all risk for loss, damage or injury (including death) to myself and my property from any cause whatsoever and whether or not attributable to the negligence of others.

In accepting this receipt the applicant, individual or company tending the payment specified, formally and with full knowledge

and authority over his own acts, and acknowledging his authority to so act for his company or business concern, subscribes to and declares himself willing to be bound by the official published regulations of the Board of Governors, A.R.D.C. and any modifications of them; and further recognizes that the interest of the Board of Governors in any activities related to this payment is purely advisory, being without responsibility or profit, and therefore releases the Board of Governors and the A.R.D.C. and their agents, employees, representatives and officials from any and all liability for personal injuries that may be received, and from all claims and demands for damages to personal property or to an agent or employee of the applicant, growing out of or resulting from participation in any capacity in any event whatsoever contemplated or held under those regulations or caused by any construction or condition of any track or tracks, equipment cars, or other devices used thereon; and further I herewith make application, pursuant to the Official Rules of the Board of Governors of the American Racing Drivers Club for Annual License for the year for as stated above, and certify that all of the following information and answers given are a true account of myself and of the construction and equipment of the car named:
